THE INDUSTRIAL RELATIONS ACT, 2000 (Act No. 1 of 2000)

APPOINTMENT OF MEMBERS OF THE LABOUR ADVISORY BOARD NOTICE, 2001 (Under Section 23)

In exercise of the powers conferred by Section 23 of the Industrial Relations Act, 2000 the Minister for Enterprise & Employment makes the following notice:-

Citation and Commencement

1. This Notice may be cited as the Appointment of Members of the Labour Advisory Board Notice, 2001 and shall be deemed to have come into force on the 25th September, 2001.
