**LEGAL NOTICE NO. 148 OF 2001**

**THE UMBUTFO SWAZILAND DEFENCE FORCE ORDER, 1977**  
(Order No. 10 of 1977)

**THE UMBUTFO SWAZILAND DEFENCE FORCE (REMUNERATION)**  
**REGULATIONS, 2001**  
(Under Section 34)

In exercise of the powers vested in me by section 34 of the Umbutfo Swaziland Defence Force Order, 1977, **I, MSWATI III, KING OF SWAZILAND**, on the advice of the Army commander, hereby make the following Regulations -

*Citation and commencement*

1. These Regulations may be cited as the Umbutfo Swaziland Defence Force (Remuneration) Regulations, 2001 and shall be deemed to have come into force on the 1<sup>st</sup> April, 2001.

*Remuneration of members of the Defence Force*

2. The remuneration of the members of the Umbutfo Swaziland Defence Force shall be as set out in the Schedule hereto.

*Revocation of Legal Notice No. 160 of 2000*

3. The Umbutfo Swaziland Defence Force (Remuneration) Regulations, 2000 are hereby revoked.
