## LEGAL NOTICE NO. 66 OF 2007

THE COMMISSIONS OF ENQUIRY ACT, 1963  
(Act No. 35 of 1963)THE APPOINTMENT OF THE KING'S CUP GOLF TOURNAMENT  
TASK TEAM NOTICE, 2007  
(Under Section 3)

In exercise of the powers conferred by Section 3 and 5 of the Commissions of Enquiry Act, 1963, the Minister for Tourism, Environment and Communications issues the following notice.

***Citation and Commencement***

1. This Notice may be cited as the Appointment of the King's Cup Golf Tournament Task Team and shall be deemed to have come into force on April 1, 2007.

***Establishment and appointment of members of the Task Team***

2. (1) There is hereby established a committee to be known as the King's Cup Golf Tournament Task Team (hereinafter referred to as "the Task Team") to operate for a period not exceeding 30<sup>th</sup> March 2008.

- (2) The Task Team shall be composed of the following members-

- (3) The quorum of the Task Team shall be four members including the Chairperson.

***Functions of the Task Team***

3. The Task Team shall -

- (a) overall management the King's Cup Golf Tournament 2007;
- (b) scout for funding and sponsorship of the event;

- (c) organize dates and venue for the event, in consultation with the relevant stakeholders;
- (d) co-opt expertise where necessary;
- (e) liaise with other local or foreign professional and amateur golfers associations on the logistics of the King's cup; and
- (f) report to the Honourable Ministries for Tourism.

***Meetings***

4. The Task Team shall meet four times a month at the Ministry of Tourism, Environment and Communications or such other place and times as the Chairperson may determine.

***Submission of report***

5. (1) The Task Team shall give progress reports on the preparations of the 2007 event shall be made to the Minister periodically.

(2) The Task Team shall present its final report of the event to the Minister before the 30<sup>th</sup> October, 2007 or on such date as the Minister may determine.

***Remuneration of the members of the Task Team***

6. The members of the Task Team shall be paid sitting allowances in accordance with Government Finance Circular No. 2 of 2005.
