## LEGAL NOTICE NO. 115 OF 2007

THE COMMISSION OF ENQUIRY ACT, 1963  
(Act No. 35 of 1963)APPOINTMENT OF THE WATER CRISIS TASK TEAM NOTICE, 2007  
(Under Section 3)

In exercise of the powers conferred by Section 3 of the Commission of Enquiry Act of 1963, the Minister of Regional Development and Youth Affairs issues the following Notice -

***Citation and Commencement***

1. (1) This Notice may be cited as the Appointment of the Water Crisis TaskTeam, Notice, 2007.

(2) This Notice shall be deemed to have come into force 1<sup>st</sup> April, 2007.

***Appointment of the Task Team***

***Functions of the Task Team***

3. The Task Team shall -

- (a) assess drought stricken areas to determine water shortage;

- (b) supervise the distribution of water in the drought stricken areas; and
- (c) provide a status report with intervention solutions and a budget estimate for the implementation of these interventions.

***Terms of Office***

4. (1) The term of office of the Task Team shall be twelve (12) months commencing 1<sup>st</sup> April, 2007.

(2) The Minister may, by notice published in the Gazette, extend the term of office for the Task Team.

***Payment of the Task Team***

5. The Task Team shall be paid such allowances and where applicable reimbursement for traveling expenses in accordance with Finance Circular No. 4 of 1998, and other circulars that may from time to time be implemented.

***Meetings***

6. During its term in office, the Task Team shall meet weekly during its term of office.

***Quorum***

7. The Chairperson or his delegated authority and four (4) members shall constitute a quorum.

***Submission of report***

8. The Task Team shall submit monthly reports.

***Resources***

9. (1) The Task Team has authority to mobilize all Government resources that may be deemed necessary to execute their operations.

(2) Implementation funding for the operations will be the Disaster Fund.
