#### LEGAL NOTICE NO. 135 OF 2007

### THE COMMISSIONS OF ENQUIRY ACT, 1963 (Act No. 35 of 1963)

## THE ESTABLISHMENT OF PROJECT STREERING COMMITTEE OF THE CHILDREN CO-ORDINATION UNIT NOTICE, 2007 (Under Section 3)

In exercise of the powers conferred by Section 3 of the Commissions of Enquiry, 1963, the Minister of Finance makes the following Notice-

#### Citation

1. This Notice may be cited as the Establishment of the Project Steering Committee of the Children Co-ordination Unit (Orphans and Vulnerable Children) Notice, 2007 and shall come into force on the date of publication.

#### Establishment of the Committee

2. There is established a Project Steering Committee to be known as the Project Steering Committee of the Children Co-ordination Unit (Orphans and Vulnerable Children).

#### Composition of Committee

- 3. The Committee shall be composed of -
  - (a) the Principal Secretary, Deputy Prime Minister's Office or a representative, who shall be the Chairperson;
  - (b) the Principal Secretary, Ministry of Finance or representative;
  - (c) the Principal Secretary, Ministry of Economic Planning and Development or a representative;
  - (d) the Principal Secretary, Ministry of Education or a representative;
  - (e) the Principal Secretary, Ministry of Health or a representative;
  - (f) the Principal Secretary, Ministry of Justice and Constitutional Affairs or a representative;
  - (g) the Principal Secretary, Ministry of Regional Development and Youth Affairs or a representative;
  - (h) the Director, Save the Chidren Fund;
  - (i) the Director, Co-ordination of Assembly of NGOs; and
  - (j) the Director, National Children's Co-ordination Unit, who shall be the Secretary.

#### Functions of Committee

- 4. The Committee shall -
  - (a) provide policy direction to the Unit;
  - (b) review the progress of implementation of projects under the Unit;
  - (c) advise the Minister on issues pertaining to the Children Co-ordination Unit;
  - (d) approve the budget and action plan of the Unit; and
  - (e) mobilize, receive and allocate resources from Government and other sources in line with its budget and action plan.

#### Allowances

5. The Committee shall be paid such allowances as are applicable to statutory boards.

#### Duration

6. The duration of the work of the Committee shall be three years.
