THE CONSTITUTION OF SWAZILAND ACT, 1968 (Act No. 1 of 2005)

THE PRESCRIPTION OF STATUTORY SALARIES AND ALLOWANCES OF OFFICERS OF THE SUPERIOR COURTS NOTICE, 2007 (Under Section 208)

In exercise of the powers conferred by Section 208 of the Constitution of Swaziland, 2005, the Minister of Finance hereby issues the following Notice -

Citation and Commencement

1. This Notice may be cited as the Prescription of Statutory Salaries and Allowances Notice, 2007, and shall be deemed to have come into force on the 1st April, 2007.

Prescription of Salaries and Allowances

2. Without prejudice to any other benefits conferred by any law, the holder of an office specified in the first column of the Schedule shall be paid not less than the salary or allowance or both (as the case may be) specified in relation to the holder, in the second, third, fourth, fifth, sixth, seventh, eighth and ninth columns of the Schedule.

Revocation of Legal Notices

3. (1) Legal Notice No. 61 of 2006 is hereby repealed to the extent that, that Legal Notice affects holders of the post of Chief Justice, Judge President and Judge of the High Court.

(2) Legal Notice No. 164 of 2007 is hereby revoked from the date of its publication.
